

Introduction

The Action Planning Weekend brought together experts from the local community, from local organisations, and from outside the town. It took 9 months to plan, and was organised and facilitated by a team of people drawn from these groups.

The "weekend" actually lasted four days:

Friday

Briefings and tours of the area for the "team"

Saturday

Public open day with workshops and Planning for Real exercises

Sunday

Team working day to develop proposals and draft the event report

Monday

Presentation of the proposals and report at an Open Meeting

This report sums up the main themes and proposals that came out of the event and the recommendations of

the Action Planning Team. It is hoped that these will help to shape a brighter future for the Ore Valley and that the energy and commitment generated will be kept up over the coming months and years.

Community Participation and Concerns for the

Future

There is a strong desire by the local community for real involvement and control over decision-making processes regarding the future of the Ore Valley and the running of local facilities.

Employment and Training

There is a high level of local unemployment made worse by a lack of incentive to work due to low wages and the benefit trap, an absence of affordable child care facilities, limited and expensive



public transport and shortage of appropriate training.

Housing Quality

There is concern about the high turnover of residents, the standard of housing and an allocation policy that leads to children being raised in flats.

Key themes that emerged

Community and Social Provision

There is an urgent need for major improvements in community facilities, particularly better and more accessible health services, improved child care and the need for a new flexible Community Centre in the Farley Bank area.

Safety and Security

Safety and security are serious concerns, particularly in connection with play areas for young children, hazards of crossing busy roads and general crime and anti-social behaviour.

Information and Communication


Improved communication is needed between community groups and agencies, including the Police, the Health service, Housing Associations, the Education Authority, the Council, Residents Groups and the residents themselves.

Movement and Transport

There is a strong desire to create a safe, clean, well-lit movement and transport network throughout the area which does not rely on private motorised transportation. Transport links need to be improved both within the area and to other parts of the town.

Ecology and Environment

There is a strong desire to protect and enhance the natural environment and to provide safe havens for existing wildlife. There are also broader environmental concerns such as pollution and the provision of recycling facilities.



Sport and Leisure Facilities

There is concern about the lack of low-cost sport and leisure facilities for adults and young people.

Image

A new positive image and identity for the area is needed to counter the negative perceptions often held by outsiders and portrayed in the media.

Young people

More facilities for young people are urgently needed, particularly in the age range 8 to 16 years. Young people need to be involved in decision making about the future of the area.

Main recommendations

Community Participation

Residents should be at the centre of the regeneration process. The Ore Valley Forum should be revitalised and properly resourced to act as the umbrella body for the projects set out in this report and bring together residents associations and representatives of all other affected parties. An Ore Valley Development Trust could be set up to maximise fundraising opportunities and develop locally-owned projects.

Local Management


Planning and management for the Ore Valley should take place in the Ore Valley, perhaps based in a new community planning office or resource centre, building on the recently established Oasis centre and community flat. This should start with the consultants undertaking the SRB feasibility study.

Ore Valley Strategy

An Ore Valley Strategy should be drawn up and agreed by all parties before any decisions are taken that affect the layout and design of the area. It should include a three-dimensional urban design strategy, and form the basis for planning guidance to ensure quality development is achieved. The ideas drawn up over the action planning weekend provide a starting point for discussion.

Immediate Action

A series of immediate actions should be taken to tackle minor 'eyesores' and other local concerns and create confidence. Such things might include improving Farley Bank football pitch and seeking planning permission for a safe play street at Lower Farley Bank.



Ideas and proposals

Ore Valley Forum

This body, which draws together
Residents Associations, community
groups and agencies, needs
regenerating and resourcing. It
should be chaired by a local
Councillor and adopted as a formal

advisory group to Hastings Borough Council and Hastings Regeneration Partnership.



Resident network and issue groups

Local residents should be recruited to co-convene the Ore Valley Forum's issue groups. They would be paid £10 per week for 2 hours work. Their co-convenor would be a professional working in a relevant agency.

Local Environmental Management Structures

New structures should be established to allow for local management of communal areas such as nature areas, pathways and play areas.

Schools and the police could assist with this.

Security

Neighbourhood Watch areas should be promoted and new schemes developed. Footpath networks should be better lit, including areas around housing.

Design and Development brief

Once the overall urban design strategy has been agreed, design and development briefs should be drawn up for critical areas to which developers can respond.

Housing Plan

A comprehensive housing plan

should be drawn up in consultation with local residents. It should include an assessment of whether any further housing in the Valley is desirable, which housing needs to be replaced and adapted, and whether there should be a greater tenure

Coordination of land owners

The various land owners in the

Valley should co-ordinate their activities to ensure a comprehensive approach. It might be helpful for English Partnerships to 'compulsory' purchase certain areas. A seminar for all land owners would be a good starting point.

"Jobs Now"

Led by an organisation with expertise in community enterprise, this project would employ residents to carry out a local skills and economy survey. The project would link with the Job Centre and Sussex University's local work.

New employment uses

Rather than a conventional industrial estate, new employment could include further education, a training centre, combined living and working studio units and a variety of sizes of serviced workspace. In addition, at the Hughenden Road/Parker Road corner, commercial and leisure uses could be introduced as part of a new Station Square.

Road to employment area

There is strong local objection to the proposed new access road to the employment area below Farley Bank. It would significantly detract from the natural environment of the

valley and would be very costly. It is important to encourage employment that can be serviced by the existing network and there are other ways in which road access could be provided from Mount Pleasant Road.

Ore Station Revitalisation

Ore Station should be improved to attract more people to use the rail service and to bring people into the new employment area. This should include more frequent and through services, better access and secure cycle parking.

Community bus service

Bus services should be upgraded with new routes, more frequent service and better timetable information. The feasibility of establishing a Community Hopper service should be investigated to access centralised health services and the new station.

Road Safety


Priory Road and Frederick Road urgently require extra pedestrian crossing facilities. Speed reduction on these roads and those within the Ore Valley should be implemented. The possibility of introducing schemes which discourage the use of

Open Space

The existing areas of woodland and open space should be protected and linked into a coherent network of linear parks. They should be made accessible and safe and become the focus for new leisure, new nature interpretation facilities and play opportunities. Surface water from surrounding areas should be led into wetland areas and the lost watercourses re-established. A Nature Reserve should be established to protect wildlife. vehicles within residential areas should be explored.

Greenways and Cycle links

The pedestrian links throughout the Valley should be reinstated and reinforced. These should include links down and across the valley area and into adjacent areas such as Ore Village via Victoria Avenue. Footpaths should be well lit and properly maintained. A cycleway should be established along the valley running from the Ridge in the north to Alexandra Park and the Town Centre in the South.



Power station

There could be enormous potential in reusing the spacious interiors of the power station for sports and leisure purposes and its image could be dramatically transformed. A full feasibility study should be undertaken.

Local Centres

The area as a whole needs a strong community focus uniting Broomgrove and Farley Bank. It should be a lively public. space including health services, leisure, sports and recreation, cates and shops. The new centre should include good access to the upgraded rallway station. Existing Local Centres such as Malvern Way should be improved by providing more facilities, better links to footpaths, new planting, seating and lighting. Service and parking areas, should also be carefully considered. A new local centre could be provided as part of the development of the Hospital land north of Farley Bank.

Action for Children

This should include regular maintenance of existing play areas and natural areas used for unstructured play and provision of some supervised play activities and regular organised events. There is a need to establish the principle of safe play streets throughout the Ore Valley with the immediate provision of a Safe Street in lower Farley Bank. The allocation of space for skateboarding and BMX tracks and levelling football pitches, building the adventure playground and kickabout/basketball areas is required.

Action for young people

A Plan of action is required to provide better facilities for young people. There is a need for indoor space for pool tables, loud music, fitness and other leisure pursuits.

Community Newspaper

A regular local newspaper should be established to improve communications within the area, more liaison between the agencies involved in the area and develop local talent. This could be linked with providing a local press officer promoting a positive image in the existing local and regional media.


